**THE LAND ACQUISITION ACT (CHAPTER 460)**

**Declaration under Section 5**

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two(2) allotments of land called Millagahawatta Amunuwela, in extent of 1.84002 Hectares, depicted as 2 lots in the plan No. 274 prepared by Mr. M. M. S. Fernando, Licenced Surveyor, situated in Godagama village in Homagama pradeshya Sabha Division in Hewagama Korale Palpathuwa in Homagama Divisional Secretary's Division in Colombo District and Bounded as follows:
