THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

Reference No.: Maprale 3/2/Jala/2002/4.

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land, which is required for a public purpose.

Description of the land to be acquired:

Five (5) allotments of land bearing in extent about 0.0132 Hectare, depicted in the Preliminary Plan No. Maha. 5645 and dated 13th October, 2004, prepared by Surveyor-General, situated in No. 16, Grama Niladhari's Division of Deyyannewela, in the village of Deyyannewela (now Hantana) in the Minor Division of Kandy, and Gangawata Korale in the Divisional Secretary's Division of Kandy and Gangawata Korale in Kandy District.
