FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE HORANA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Horana Pradeshiya Sabha has fallen vacant by reason of death ;
