THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Rajitha Senaratne, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land called Enasaldora Watta in Extent about 0.0289 Hectare shown as Lot A, B and C in the Advance Tracing No.: Maha/HRS/2003/39 of 16.03.2003, prepared by Surveyor-General, situated in the village of Bolagala, Medasiyapattuwa Minor Division, Harispattuwa Divisional Secretary's Division, Kandy District and bounded as follows:

1. Lot "A" – Enasaldora Watta – Extent: About 0.0082 Hectare
