THE AWARD

The Hon. Minister of Employment and Labour by virtue of the powers vested in him by Section 4(1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by Act, Nos. 14 of 1957, 62 of 1957, 4 of 1962 and 39 of 1968 (read with Industrial Disputes (Special Provisions) Act, No. 37 of 1968) appointed me as Arbitrator by his order dated 03.07.2002 and referred the aforesaid dispute to me for settlement by arbitration.

The matter in dispute between the aforesaid parties is whether the non payment cost of living allowance by Alumex (Pvt) Limited from the year 1997 to Messrs. M. K. Ekman Singho, D. V. Jayatilake and W. A. Alfred who were employees of the said company is justified and if not to what relief each of them is entitled.

The parties to the dispute settled the matter by the company paying each of the said workers Rs. 12,000.

In view of the above I make no further award.
