THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

The Land called Villuthottam depicted as “Lot No. 1” in Plan No. P. P. Pu. 3918 dated 05.10.2001 and prepared by the Surveyor-General, in extent about 0.0426 Hectare within the following boundaries situated in the village Tammanna Adaviya, Ward No. 3 Limit Puttalam and Puttalam Divisional Secretary’s Division of Puttalam District.

North: Anuradhapura Road; East: Villuthottam, Assmt. No. 215/46, Anuradhapura Road, Coconut Garden of R. Kumarasinghe; South: Villuthottam, Assmt. No. 214/46, Anuradhapura Road, Coconut garden of R. Kumarasinghe and Villuthottam, Assmt. No. (Not available) Anuradhapura Road, Chena of D. Rapiel; West: Villuthottam, Assmt. No. (Not available), Anuradhapura Road, Chena of D. Rapiel.

All persons interested in the aforesaid land are hereby required to appear personally, or by agents duly authorized in writing, before me at Puttalam Divisional Secretariat on the 21st day of September 2004, at 10.00 a.m. and are hereby requested to notify to me in writing (in duplicate) on or before the 7th day of September 2004 the nature of their interests in the land, the particulars of their claims for compensation for the acquisition of the said land, the amount of compensation and the details of the computation of such amount.

Further, written document should be submitted in duplicate before 7th september 2004 with regard to any claims about the ownership of

the land and reasons, details for claiming compensation and how the amount of compensation was calculated.
