Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

Eleven allotments of lands in total extent about 0.0130 Hectare shown as Lot No. 01 - 11 in Advance Tracing No. Co/Mo/SLRDC/2003/332 and dated 14/10/2003 prepared by the Surveyor-general, situated, in Salpita Korale, in Kawdana and Watarappala villages in the Divisional Secretary's Division of Ratmalana in the District of Colombo and bounded as follows:

01. Lot A – Extent: 0.0005 Hectare

North: Abeysekera Road and canal; East: Ela and balance part of the land; South: Balance part of the land and Lot B; West: Lot B and Abeysekera Road.

02. Lot B – Extent: 0.0010 Hectare

North: Abeysekera Road and Lot A; East: Lot A and balance part of the land; South: Balance part of the land and Lot C; West: Lot C and Abeysekera Road.

03. Lot C – No. 118G, Abeysekera Road (Part) – Extent: 0.0009 Hectare

North: Abeysekera Road and Lot B; East: Lot B and No. 118G; South: No. 118G and Lot D; West: Lot D and Abeysekera Road.

04. Lot D – No. 118E, Abeysekera Road (Part) – Extent: 0.0009 Hectare

North: Abeysekera Road and Lot C; East: Lot C and No. 118E (Balance part of the land); South: No. 118E (Balance part of the land) and 118B, Abeysekera Road West: Abeysekera Road.

05. Lot E – No. 116B, Abeysekera Road (Part) – Extent: 0.0009 Hectare

North: Abeysekera Road; East: Abeysekera Road and No. 116B (Balance part of the land); South: No. 116B (Balance part of the land) and Lot F; West: Lot F and Abeysekera Road.

06. Lot F – No. 116A, Abeysekera Road (Part) – Extent: 0.0005 Hectare

North: Abeysekera Road and Lot E; East: Lot E and No. 116A (Balance part of the land); South: No. 116A (Balance part of the land) and 116, Abeysekera Road; West: Abeysekera Road.

07. Lot G – No. 97, Abeysekera Road (Part) – Extent: 0.0008 Hectare

North: No. 97 (Balance part of the land) and Road; East: Road and Abeysekera Road; South: Abeysekera Road; West: 91/47, Abeysekera Road and No. 97, Abeysekera Road (Balance part of the land).

08. Lot H – Extent: 0.0010 Hectare

North: Balance part of the land and Lot I; East: Lot I and Abeysekera Road; South: Abeysekera Road and Road; West: Road and Balance part of the land.

09. Lot I – Extent: 0.0009 Hectare

North: Balance part of the land and Road; East: Road and Abeysekera Road; South: Abeysekera Road and Lot H; West: Lot H and balance part of the land.

10. Lot J – No. 109/1, Abeysekera Road (Part) – Extent: 0.0003 Hectare

North: No. 109/1 (Balance part of the land) and Lot K; East: Abeysekera Road and Lot K; South: Abeysekera Road and Road; West: Road and No. 109/1 (Balance part of the land)

11. Lot K – No. 109, Abeysekera Road (Part) – Extent: 0.0053 Hectare

North: No. 109 (Balance part of the land) and No. 99B, Abeysekera Road; East: Abeysekera Road; South: Abeysekera Road and Lot J; West: Lot J and No. 109 (Balance part of the land).
