#### FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE ATTANAGALLA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Attanagalla Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party ;

And whereas the Secretary of the People's Alliance, the recognised political party to which Mr. A. A. D. P.
