PART I : SECTION (I) — GENERAL

Government Notifications

SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14 (1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Chandrika Bandaranaike Kumaratunga, President of the Democratic Socialist Republic of Sri Lanka with the concurrence of the Minister of Finance, do by this Order, determine that with effect from 04th November, 2004, a cess shall be charged, levied and paid on all goods enumerated in Column III of the Schedule hereto on their value for Customs duty purposes at rates specified in the corresponding entry in Column IV of that Schedule, at the time of importation. Wherever *ad valorem* and unit rates are specified, the rate whichever is higher, should be applicable for the payment of this cess.

This cess shall be in addition to the cess already in force in terms of the *Gaette Notification* No. 792/13 of 10th November, 1993.
