#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Dissanayake Mudiyanse Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Dissanayake Mudiyanse Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude described below is required for a public purpose and will be acquired under the provisions of that Act.

Description of servitude.– Right of servitude for the purpose of laying and maintenance of pipelines.
