FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE BIYAGAMA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the Office of a member in Biyagama Pradeshiya Sabha has fallen vacant by reason of being appointed as a member of the Western Province Provincial Council ;

And whereas the Secretary of the People's Alliance, the recognised political party to which Mr. Narangoda Liyanage Gunasiri Jayanath the member belonged, was required by me under Section 65A (2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Biyagama Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of one month ;

And whereas the Secretary of the aforesaid recognised political party has failed to communicate his decision within the period specified ;

Now therefore I, Mohamad Mahdoom Mohamad Returning Officer of Biyagama Pradeshiya Sabha, acting in terms of Section 65A (2) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Ahuliyadde Lekamalage Karunarathna who had secured the next highest number of preference to the last of the member declared elected at the election of members held on 20th of March, 2002 to Biyagama Pradeshiya Sabha in respect of which such vacancy occurred.
