NOTICE OF CANCELLATION (SECTION 104) OF THE CROWN GRANT ISSUED UNDER SECTION 19,
SUB-SECTION (4) OF THE LAND DEVELOPMENT ORDINANCE

I, A. M. R. J. Jayasinghe, Divisional Secretary of the Wanathawilluwa Division comes under the North Western Provincial Council, do hereby notify that the land mentioned in the Schedule hereto was granted to Kalubowilage Jerald Indrajith Perera of No. 25, De Zoysa Flats, Moratuwa by the Hon. Governor General William Gopallawa on the 12th day of March, 1970 on a Crown Grant bearing No. 9467 under the Land Development Ordinance, Section 19, Sub-section (4) and the said land was registered at the Office of the Land Registry, Puttalam on 11.11.1996 under R. 9467 in L.D.O. 77/77 register and there is no legal person claimed for the heirship of the said land mentioned in the Schedule hereto or even if there is a legal heir, he or she is unwilling to be the successor of the said land. Thereby it is reported that there is no one interested to be appointed as the successor of the land mentioned in the Schedule hereto. Therefore steps have been taken to cancel the said Crown Grant under Section 104 of the said Act. Any objections to the cancellation of the said Grant shall be forwarded to me before the 15th October, 2004.
