THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Dissanayake Mudiyanseelage Anura Kumara Dissanayake, Agriculture, Livestock, Lands and Irrigation Minister, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

The land called Hewagewatte *alias* Gorakawitiyalawatta in extent about 0.4004 hectare as shown as lots number A to E mentioned in Survey General's Advanced tracing dated 2004.03.30 and No. MR/MTR/2004/97, situated in the village of Kekanadura, Grama Niladhari Division of Kekanadura Central, Divisional Secretariat of Matara, in the Matara District of Southern Province.

Divisional Secretariat of Matara in the Matara District situated in the village of Kekanadura, prepared by Survey General No. MR/MTR/2004/97 and dated 2004.03.30 depicted in Advance tracing lots No. ABCD and E as shown from the total extent about 0.4004 hectare mentioned below by names, extents and boundaries with the land blocks.
