FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE HARISPATTUWA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Harispattuwa Pradeshiya Sabha has fallen vacant by reason of death ;

And whereas the Secretary of the United National Party, the recognised political party to which Zeinul Abdeen Mohamud Razak, the member belonged, was required by me under Section 65A (2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Harispattuwa Pradeshiya Sabha who belongs to such party who shall be declared elected as a member within a period of thirty (30) days ;

FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE UDUNUWARA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
