FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE NELUWA PRADESHIYA SABHA UNDER SECTION 65A (1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of the Chairman in Neluwa Pradeshiya Sabha has fallen vacant by reason of death ;

And whereas the Secretary of the People's Alliance, the recognised political party to which Miyanawathura Ihalagamage David the Chairman belonged, was required by me under Section 65A (1) of the aforesaid Ordinance, to decide upon the member of that Neluwa Pradeshiya Sabha who belongs to such party who shall be declared elected as the Chairman within a period of thirty (30) days ;

And whereas the Secretary of the aforesaid recognised political party has failed to communicate his decision within the period specified ;

Now therefore, I, Madduma Kankanamalage Bandula Harischandra, Returning Officer of the Neluwa Pradeshiya Sabha, acting in terms of Section 65A (1) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Upul Priyantha Kumara Wijenayaka who had secured the next highest number of preferences next to the last of the member declared elected at the election of members, held on 20th of March, 2002 to Neluwa Pradeshiya Sabha elected as the Chairman of the Neluwa Pradeshiya Sabha in respect of which such vacancy occurred.
