11 : 05 Rs. 250 in existing 11 : 05 is amended as Rs. 600

15 : IV Existing 15 : IV is amended as follows :

In line one “Bus” is amended to read as “Bus / Van” and in the same paragraph ordinary bus services amended to read as “Bus / Van” services and in para (i) Buses less than 25 seats amended to read as “Bus / Van” and luxury buses in the same paragraph amended to read as luxury “Buses/Vans” and Buses less than 25 seats in

para (i) amended to read as "Buses / Vans".

16 (a) Fees for conducting training courses and issuing licences by the Driver Training Schools amended as follows :

Existing clause 16 (g) will be deleted and the following clauses are substituted therefor : -

16 (g) When obtaining a Permit following Service Charges will be levied in addition to Permit :

For an "A" Route	- 52,500
For a "B" Route	- 43,750
For a "C" Route	- 35,000
For "D" and "E" Routes	- 26,250
For Luxury Buses	- 54,000

When levying Service Charges in addition to Service Charges Monthly Running Chart or Entrance Charges should be levied with Permit Charges.

When the ownership is changed and when issuing New Permits the following clauses will be added immediately after the clause 16 (g) as clause 16 (h).

- (h) (i) When the ownership is changed and when issuing New Permits full Service charges according to the route classification and when only the Bus is changed only Permit Charges ;
- (ii) When the ownership is changed among Mother / Father / Brothers / Sisters of the same family, only Permit Charges should be levied after getting the identity established.
