FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE MAHARA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of the member in Mahara Pradeshiya Sabha has fallen vacant by reason of being appointed as a member of the Western Province Provincial Council ;

And whereas the Secretary of the People's Alliance, the recognised Political Party to which Mr. R. P. Dilip Kumara Rajapaksa , the member belonged, was required by me under Section 65A (2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for Election as a member of that Mahara Pradeshiya Sabha who belongs to such Party who shall be declared elected as the member within a period of one month ;
