Order under Section 3

BY virtue of the powers vested in me under Section 3 of the Mediation (Special Categories of Disputes) Act, No. 21 of 2003, I, Welatantrige Don John Seneviratne, Minister of Justice and Judicial Reforms do by this Order, specify that the areas specified in Column II of the Schedule hereto are areas within which the settlement of any dispute belonging to the category specified in Column I of the Schedule hereto, shall be carried out under the provisions of the Mediation (Special Categories of Disputes) Act, No. 21 of 2003.
