FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KARUWALAGASWEWA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a Member in Karuwalagaswewa Pradeshiya Sabha has fallen vacant by the reason of not attending meeting of the council for a period of three months without permission;
