#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands & Irrigation, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands & Irrigation, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The following 09 blocks of land, in extent of about 0.1284 Hectare, depicted as blocks 01 to 09 in the plan No. 384/1988 dated 06.05.1998 prepared by the licensed Surveyor Mr. Kannangara situated in the village of Yathramulla in Pradeshiya Saba area in Divisional Secretary's Division in the Galle District and the names, extents and boundaries are given below.

##### **01. Lot No. 01 – Thappawatta – Extent: About 0.0055 Hectare**

North: Remaining portion of the land; East: Circular road; South: Road; West: Lot No. 2 in this Plan.
