#### REGULATIONS UNDER THE MOTOR VEHICLE STATUTE No. 7 OF 1991 OF THE WESTERN PROVINCE

REGULATION made under Section 129(1) of the Motor Vehicles Statute No. 7 of 1991 of the Western Province by the Chief Minister and Minister of Finance, Planning and Implementation, Law and Order, Local Government and Provincial Administration, Education, Transport, Employment, Cultural and Arts Affairs.

#### Regulation

This regulation shall be known as the Motor Vehicles Fees (Amendment) Regulation and shall be in operation from 26th December 2004 upto 25th June 2005.

Where a period of six months has not elapsed from the date stipulated for the payment of licence fees, the owners of the vehicles of the Western Province. Destroyed within the areas affected by the Tsunami on 26th December 2004 and the (displaced) owners of the vehicles who failed to travel to the Licensing Authority, owing to the Tsunami, will, subject to the terms stipulated below, be exempted from the requirement of paying the penalty of 10% of the licence fees imposed by the Minister of Transport, Highways, Economic Infrastructure, Trade, Housing, Construction, Rural Development and Council Affairs and published under the title “penalty” in para (g) in the regulation on the Motor Vehicle Fees - 1992 published in para IV (a) of the *Gazette* No. 711 dated 15.04.1992.

- \* Fees could be accepted with no penalty only in respect of the vehicles for which licenses had to be obtained after 24.12.2004.
- \* This concession is granted only to the Divisional Secretariats affected by Tsunami, to the vehicle owners who being persons affected by Tsunami failed to travel to the appropriate licensing authority and to the affected vehicles. Any acceptable evidence or the recommendation/authority of the Divisional Secretary is required for this purpose.
