**FILLING OF A VACANCY IN THE OFFICE OF VICE CHAIRMAN OF THE YATINUWARA PRADESHIYA SABHA UNDER SECTION 65A (1) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS the office of The Vice Chairman in Yatinuwara Pradeshiya Sabha has fallen vacant by reason of resignation ;

And whereas the Secretary of the United National Party, the recognised Political Party to which Mr. H. B. Jayatilake, the Vice Chairman belonged, was required by me under Section 65A (1) of the aforesaid Ordinance, to decide upon the member of that Yatinuwara Pradeshiya Sabha who belongs to such Party who shall be declared elected as the Vice Chairman within a period of thirty days ;

And whereas the Secretary of the aforesaid recognised Political Party has communicated his decision to nominate Mr. Abesiriwardana Sarathhamu Karunarathna to fill such vacancy ;

Now therefore, I, Wanasinghe Mudiyanseelage Pahala Gedera Wickramasinghe, Returning Officer of Yatinuwara Pradeshiya Sabha, acting in terms of Section 65A (1) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare that Mr. Abesiriwardana Sarathhamu Karunarathna elected as the Vice Chairman of the Yatinuwara Pradeshiya Sabha.

**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KALUTARA PRADESHIYA SABHA UNDER  
SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS the office of a member in Kalutara Pradeshiya Sabha has fallen vacant by reason of not attending more than three consecutive meetings without permission ;

And whereas the Secretary of the People's Alliance, the recognised Political Party to which Mr. Juwan Mandadige Somasiri, the member belonged, was required by me under Section 65A (2) of the aforesaid Ordinance, to nominate a person eligible under the Ordinance for election as a member of that Kalutara Pradeshiya Sabha who belongs to such Party who shall be declared elected as a member, within a period of 30 days ;

And whereas the Secretary of the aforesaid recognised Political Party has failed to communicate his decision within the period specified.

Now therefore, I, Chandrarathana Pallegama, Returning Officer of Kalutara Pradeshiya Sabha, acting in terms of Section 65A (2) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare Mr. Vidana Pathiranage Luxman who had secured the highest number of preferences next to the last of the member declared elected at the election held on 20th May, 2002 to Kalutara Pradeshiya Sabha elected as a member of the Kalutara Pradeshiya Sabha in respect of which such vacancy occurred.
