#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Disanayake, Minister of Agriculture, Livestock, Lands and Irrigation hereby declare under sub-Section (1) of section 05 of the land Acquisition Act. that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Details of the land - situated in Uva-Province, Badulla District Haldummulla Divisional Secretariat, Kandapalla korale sulu Division, Vharagala Gramaniladari Divisional blackwood Estate gama. The land extent of Hectares 6.418 as shown in the Survey plan No. B/ RDE/2003/1052 at 2004.04.24 of Surveyor-General. This land is situated at Blackwood Estate Gama.

The land required public reason was to protect from land slides
