THE NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974

Order under Section 64(1)

BY virtue of the powers vested in me by Section 64 (I) of the National Water Supply and Drainage Board Act, No. 02 of 1974, I, Dinesh Gunawardhana, the Minister of Urban Development and Water Supply do, approve by this order, embody in the Schedule hereto, the provisions of the “Voluntary Transfer Scheme” approved by me under Section 63 (1) of the aforesaid Law, in connection with the Kakkapalliya Water Supply Scheme maintained by the Chilaw Pradeshiya Sabha.

SCHEDULE

Section 61(1) - contents of the Voluntary Transfer Scheme.

- (a) All under mentioned movable and immovable property shall be vested with the National Water supply and Drainage Board *viz.*
- (i) all intakes, collecting reservoirs, water storage and distribution tanks, Pumping stations of the Kakkapalliya Water supply Scheme and all lands, buildings, Pipelines, network, necessary for the implementation and maintenance of the said water supply scheme and all mechanical and electrical machinery and equipment, fixtures, and all spares, accessories and stores items necessary for the maintenance of such machinery and equipment.
- (ii) Rights of servitudes over land used for the purpose of laying pipelines, spares, accessories and stores items along with all main water supply, water distribution pipeline network necessary for the implementation and maintenance of the Water Distribution network of the Kakkapalliya Water supply Scheme.

- (b) Any contracts entered into, by the Chilaw Pradeshiya Sabha in connection with the planning, supplies, fixtures, constructions, operation and maintenance of the above mentioned, rights, obligations and liabilities of the Pradeshiya Sabha shall be transferred to the Board.
- (c) All agreement entered into by with the consumers of water, in connection with the consumption of water and provision of water supply services, all payments to be made in connection with the procurement of such services, shall be transferred to the Board.
- (d) The state shall confer the value of such facilities amounting to Rs. 1,161,000/- (Sri Lanka Rupees One point one Six One Million) as a grant to the Board.
- (e) The Board shall continue to maintain without interruption all agreements entered into, by the Pradeshiya Sabha in connection with the provision of water supply services and shall also fulfill the contractual obligations.

The said transfers shall come into operation with effect from the date of publication of this notice.
