THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land called Indipitiya in extent of about 4.104 Hectares, depicted as a Lot A in Advanced Tracing No. Ku/HRN/01/42 of 09.02.2001 prepared by the Surveyor-General, situated in the village of Kidelpitiya in Minor Division of Udugahapaththuwa, Horana Divisional Secretary's Division in Kalutara District and bounded as follows.
