### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Tissa Karalliyadda, Minister of Lands and Indigenous Medicine, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Eight (08) allotments of land in total extent of about 0.1886 Hectare, as Lot No. 01 to 08, depicted in Advance Tracing No. CO/HMG/2003/782 of 26th December, 2003, prepared by the Surveyor-General, situated in the village of Niyandagala in the Divisional Secretary's Division of Homagama in the Colombo District in the Western Province and bounded as follows:

**01. Lot No. 01 – Thulhiriyaawekumbura – Extent: 0.0452 Hectare**
