THE URBAN DEVELOPMENT AUTHORITY LAW, No. 41 OF 1978

Order under Section 3

BY virtue of the powers vested in me under Section 3 of the Urban Development Authority Law, No. 41 of 1978, I, Dinesh Chandra Rupasinghe Gunawardene, Minister of Urban Development and Water Supply being of the opinion that the area specified in Column I of the Schedule hereto and having the meets and bounds specified in corresponding entry in Column II of that Schedule, is suitable for development, do by this order declare such area to be an Urban Development Area for the purpose of that section.

SCHEDULE

GALIGAMUWA URBAN AREA

Column I

All the area of land located within Galigamuwa Pradeshiya Saba comprising the following Grama Niladhari Divisions, No. 69B Galigamuwa, No. 71 Kobbewala, No. 70C Ballapana Pathabage, No. 70D Ballapana Udabagea and No. 70E Mefield Grama Niladhari Division and No. 69C Bisowala, No. 69A Dematanpitiya, No. 69, Asideniya, No. 70A Palapoluwa of the Galigamuwa Divisional Secretariat area in Kegalle District, Sabaragamuwa Province having the meets and bounds specified in corresponding entry in Column II of this Schedule.

Column II

*North* : From the intersecting point of the centre line of Yattagoda-Batuwatta road and the centre line of Marawa road a line drawn eastwards along the centre line of Marawa road until it meets the centre line of the Gammiris Hena foot path. Thence northeastwards along the said foot path until it meets the western boundary of Porambe Grama Niladhari Division ; thence a line drawn southeastwards along the Western, Southern and Eastern boundaries of the said Grama Nialadhari Division until it meets the centre line of Kagalu Oya, thence, southeastwards along the centre line of said Oya until it meets the western boundary of Kegalle Divisional Secretariat division.

*East* : From the last mentioned point a line drawn Southwards along the Kegalle Divisional Secretariat boundary until it meets the centre line of culvert No. 3/74 on Colombo-Kandy road ; thence, a line drawn eastwards along the centre line of the said road until it meets the centre line of Ambanpitiya-Naberiya road, thence, southwards along the centre line of the said road until it meets the centre line of Kadigamuwa road.

*South* : From the last mentioned point a line drawn northwestwards along the centre line of Kadigamuwa road until it meets the centre line of Avissawela-Galigamuwa road, thence southwards along the centre line of the said road until it meets the centre line of Dematanpitiya-Aasideniya road, thence of line drawn northwestwards along the centre of the said road until it meets the northern boundary of Warakapola Divisional Secretariat Division, thence, a line drawn southwestwards along the said boundary to a distance of 370.5 m.

*West* : From the last mentioned point a line drawn northeastwards along the said boundary of Warakapola Divisional Secretariat Division until it meets the centre line of the culvert No. 1/69, on Colombo-Kandy road, thence a line drawn eastwards along the centre line of said road until it meets the centre line of Galigamuwa-Battapothella road, thence, a line drawn northeastwards along the centre line of the said road until it meets the centre of a cross road connecting Palapoluwa-Dimbiangastenna road at 635 m., thence, a line drawn northeastwards along the centre line of the said cross road until it meets the centre line of Palapoluwa-Dimbiangastenna road, thence, a line drawn southeastwards along the said road until it meets the centre line of Yattogoda-Batuwatta road, thence, a line drawn northwestwards along the centre line of the said road until it meets the starting point.
