THE JUDICATURE ACT, No. 2 OF 1978

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Judicature Act, No. 2 of 1978, I, Welathanthrige Don John Seneviratne, Minister of Justice and Judicial Reform in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order, with effect from 15th September 2005, amend the Schedule to the Order published in *Gazette Extraordinary* No. 43/3 of July 02, 1979 as last amended by Order published in *Gazette Extraordinary* No. 1360/9 of 30th September, 2004 with reference to the item “Kandy” appearing in Column I of that Schedule, under the heading “Zone”, as follows :-
