## PART I : SECTION (I) – GENERAL

### Land Reform Commission Notices

LAND REFORM ACT, NO. 1 OF 1972

Order Under Section 27A(1)

By virtue of the powers vested in me by Section 27A(1) of the Land Reform Act, No. 1 of 1972 as amended by Acts, Nos. 39 of 1975, 14 of 1981, 39 of 1981, 14 of 1986 and 18 of 1986, I, Anura Priyadarshana Yapa, Minister of Plantation Industries under the provisions of the said Act do vest under this order. The Agricultural land indicated in Schedule 1 here to vested in Land Reform Commission, in the National Housing Development Authority established under National Housing Development Authority Act, No. 17 of 1979 as amended by Act, No. 5 of 1982 for a sum of One Lakh Eleven Thousand and Three Hundred Sixty Five Rupees (Rs.111,365/-) paid to the Land Reform Commission by the said authority for a purpose indicate in schedule 2 hereto, with effect from 14th September 2005.
