Land Reform Law No. 1 of 1972

ORDER UNDER SECTION 27(A)(4)

By virtue of the powers vested in me by Section 27(A) (4) of the Land Reform Act, No. 1 of 1972 as amended by Act No. 39 of 1975, Act No. 14 of 1981, Act No. 39 of 1981, Act No. 14 of 1986 and Act No. 18 of 1986. I, Anura Priyadarshana Yapa, Minister of Plantation Industries in pursuance of the Provisions of the Order under Section 27(A) (1) of the Land Reform Law No. 1 of 1972, vesting the land called Hatale Estate, situated in Kandy District, in extent of 291.90 Hectares in Sri Lanka State Plantation Corporation established under Act No. 58 of 1958 and published in *Gazette Extraordinary of the Democratic Socialist Republic of Sri Lanka*. Part I Section (1) - General No. 181/12 of 27.02.1982 do hereby revoke the Order with effect from 23.03.2004, pertaining to the allotments referred to in the Schedules I, II, III and IV herto.
