#### Vesting Order No. 67

WHEREAS the People's Bank has determined under the provisions of Section 71(3) of the Finance Act, No. 11 of 1963 as amended by Finance and Ceylon State Mortgage Bank (amendment) Law No. 16 of 1973, Finance (amendment) Act, No. 19 of 1984 and Finance (amendment) Act, No. 36 of 2000 that the property described in the schedule hereto shall be acquired for the purpose of Part VIII of the said Act, and whereas the Chairman of the Board of Directors of the said Bank has caused such determination to be notified to the Minister of Finance under Section 72(1) of the said Act and whereas by virtue of Section 72(2) of the said Act. The Minister of Finance is empowered to vest in the People's Bank, the said property.

I, Mahinda Rajapaksa, Minister of Finance and Planning do hereby make order vesting the said property described in the schedule hereto, in the People's Bank with effect from Twenty eight day of March, Two Thousand and Seven.

- (1) All that allotment of land called Whaumpurage Watta situated at Narangastenna in Dehigampal Korale in the District of Kegalle in Sbaragamuwa Province and bounded, on the North by Hitinnawaththa, on the East by Mahakumbura, on the South by drain separating a portion of this land, on the West by Pitadeniya Kumbura and containing in extent One Acre, (1A. 0R. 0P.) and registered under Folio S 75/268 at Avissawella District Land Registry.
