Provincial Councils Notifications

IN ACCORDANCE WITH SECTION No. 122 (1) AND 126 (VII) OF PRADESHIYA SABHAS ACT.

**Sub-ordinance regarding arranging spaces for parking vehicles and charging from them in the area of
Hali Ela Pradeshiya Sabha**

1. This Sub-ordinance is called as “the sub-ordinance regarding arranging spaces for parking of vehicles and charging from them for parking at such spaces in the area of Hali-Ela Pradeshiya Sabha.

2. This Sub-ordinance is brought regarding the arrangements for parking, controlling and collecting charges from them in the area of Hali Ela Pradeshiya Sabha.

3. An instruction should be exhibited on the road or a section of it where parking is allowed/parking prohibited / limited /controlled of vehicles at a public and visible place by the chairman of the Pradeshiya Sabha called hereafter as ‘the Chairman’.

4. On the occasion of an instruction has been exhibited according to the 03rd Sub-ordinance, a driver of a vehicle must not.

- (a) Disgrace the orders/instruction exhibited on the road or in a portion of it by an officer or authorized person.
- (b) Neglect the transport system which is in practice on a particular road/street or a part of it.
- (c) Allow any person to get down from or get into the vehicle.
- (d) Park a vehicle exceeding the time needed to load or unload goods on a road/street or a part of it.

5. Parking of a vehicle is prohibited at a place which is separated to park the vehicle of a particular person unless having a permit issued by the chairman under this Sub-ordinance.

6. A fee shall be charged as shown in the schedule below on a permit which will be issued according to the sub-ordinance No. 05 above and it can be altered time to time as decided and published in a *gazette* paper by the sabha.

7. A monthly or annual permit for vehicles can be obtained by a government department/corporation/board/private company by paying the fee decided by the Sabha time to time.

8. The number of the vehicle should be denoted in every permit which issued under this Sub-ordinance and the validity of it should be limited only for the period mentioned in it.

9. Every person who received a permit under this Sub-ordinance should exhibit same on a transparent place inside the vehicle enable to see that clearly.

10. An owner or a driver should produce the permit which is issued for a particular vehicle, while a police officer or a controller of vehicles requested to submit for inspection/verification.

11. No person can park a motor vehicle which is not belongs to the particular class or kind where a place is separated for such class or kind of vehicles at a public place for vehicle parking.

12. It is not allowed to park a motor vehicle as to disturb another one to enter into a public place for vehicle parking or to exit from there.

13. No vehicle can enter into or exit from a public place for vehicle parking except through the particular ways when separated ways are used for the above purposes and instructions or signals are exhibited.

14. All the vehicles to be parked according to the arrivals, one behind the other and facing one and the same direction at a public vehicle park where chains and/or posts are provided and vehicles should be brought forward according to the suitable spaces come.

15. Washing or making arrangements to wash a vehicle is not allowed when it is parked at a public yard for vehicles.

16. Any kind of repairing of a vehicle is not allowed at a public vehicle park if compelled to repair the same to remove from there.

17. This Sub-ordinance is to be carried out every day only with in the time from 6.00 p.m. this time and duration can be changed by a *gazette* notification of the chairman.

18. On a written order of the chairman, a particular personal class can be released after paying the relevant fee.

19. A person who breaks any section of this sub-ordinance does on offence. When a court decides that he has done an offence he has to pay a five of a fine of a sum not exceeding Rs. 750/- if the particular person does the offence continuously he has to pay an additional fine of Rs.100/- for the each occasion and the sum of fine should be deposited into the general fund of the Pradeshiya Sabha.

20. If no occurred to give another meaning or the word "Chairman" in this Sub-ordinance it denotes the chairman of the Hali-Ela Pradeshiya Sabha.

21. The words "Police Officer" denote a police constable who possess a rank below the rank of an inspector.

22. The meaning of "Vehicle Controller" is, a person who is authorized to issue permits by the Chairman instead of him.

23. Any vehicle which is made to use on roads and enable to ride or drive with the support of an engine is meant by the word "Motor Vehicle"

24. "Public place for vehicle parking" is a place named by a proposal of the Pradeshiya Sabha.

25. The word "Pradeshiya Sabha" means the Hali-Ela Pradeshiya Sabha.
