Land Acquisition Notices

LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land which is required for a public purpose :-

Description of the land to be acquired : Waragaswilawatta in extent of 9.009 hectares depicted as Lot 01 in Preliminary Plan No. P.P.G. 3520 prepared by surveyor general situated in the village of Pinkanda in the Divisional Secretary's Division of Ambalangoda in Galle District and bounded as follows :
