FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE GIRIBAWA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a member in Giribawa Pradeshiya Sabha has fallen vacant by reason of resignation ;

And whereas the Secretary of the People's Liberation Front, the recognized political party to which K. A. **FILLING OF VACANCY IN THE OFFICE OF CHAIRMAN OF THE ALAYADIVEMBU PRADESHIYA SABHA
UNDER SECTION 65A (1) OF THE LOCAL AUTHORITIES ELECTIONS
ORDINANCE (CHAPTER 262)**

WHEREAS the office of the Chairman in Alayadivembu Pradeshiya Sabha has fallen vacant by reason of resignation ;
