THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

Two (02) blocks of land described below containing extent of 0.0214 hectares in depicted as Lot Nos. 1 and 2 in the Plan No. P.P. Ga. 3540 dated 04.06.2007 prepared by the Surveyor General and situated in the Village of Hapugala in the Grama Niladhari's Division of Beraliyadola in the Divisional Secretary's Division of Bope/Poddala in the Galle District of the Southern Province and bounded as follows:
