Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby notified under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of land to be acquired:

Construction of Drainage System to drain rain water from the premises of Koulahena reservoir of the Mahagalle Water Supply Scheme.

Four blocks of land containing 0.0129 Hectare in extent depicted as Lots 1 to 4 in the Plan No. 3472 dated 28.02.2006 prepared by the Surveyor-General situated in the village of Ihalagoda in the Grama Niladhari's Division of Ihalagoda West in the Divisional Secretary's Division of Akmeemana in the Galle District in the Southern Province and described as follows;
