THE LAND ACQUISITION ACT (CHAPTER 460)

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

An allotment of land called Rajawella bearing an extent of about 0.0961 Hectare depicted as Lot Nos. 03 and 04 in the P. P. Maha 5702 dated 31.07.2006, Prepared by the Surveyor General situated in the Village of Attaragalla, Pallegama, Pahalagammedda in the Minor Division of Udagampaha Korale, in the Divisional Secretary's Division of Kundasale of Kandy District, Central Province and bounded as follows:

Lot No. 03 – Rajawella – Extent: 0.0930 Hectare

North: Lot No. 01 in the same Plan and Lot No. 38 in the Plan No. P. P. Maha 2584; East: Lot Nos. 01 and 02; South: High Way

Road and Lot No. 02; West: Lot No. 38 in the Plan No. P. P. Maha 2584 and Lot No. 04, High Way Road.
