Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired :

The land acquisition to build the houses for the Tsunami victims

1. An allotment of land called Koswatta, total extent of about 3.0449 Hectares, depicted in Plan Lot No. 258 and dated on 28th July, 2006 and F.V.P. 306, situated in the village of Dedduwawela in Minor Division of South Giruwapattu in the Divisional Secretary's Division of Tangalle in Hambantota District in Southern Province and bounded as follows:

North: Lot Nos. 115D, 116D and 116E; East: Lot No. 108; South: F. V. P. 305, Moraketiara; West: Lot Nos. 164, 115C and 115B.

2. An allotment of land called Koswatta, total extent of about 1.6855 Hectares, depicted in Plan Lot No. 147 and dated on 28th July, 2006 and F.V.P. 305, situated in the village of Moraketiara in Minor Division

of South Giruwapattu in the Divisional Secretary's Division of Tangalle in Hambantota District in Southern Province and bounded as follows:

North: F. V. P. 306, Dedduwawela; East: F. V. P. 306, Dedduwawela and Lot No. 12; South: Lot Nos. 146, 12, 9A and 9B; West: Lot Nos. 9A and 9B.

All persons interested in the aforesaid lands are hereby required to appear personally, or by agents duly authorized in writing, before me at Divisional Secretariat, Tangalle on the 12th day of February, 2007, at 11.00 a.m., and are hereby requested to notify to me in writing (in duplicate) on or before the 31st day of January, 2007, the nature of their interests in the land, the particulars of their claims for compensation for the acquisition of the said land, the amount of compensation and the details of the computation of such amount.
