CUSTOMS ORDINANCE

NOTIFICATION under Section 22 (A) of the Customs Ordinance (Chapter 235) as amended by Act, No. 83 of 1988, approved by Hon. Minister of Finance, and published in the *Gazette Notification of the Democratic Socialist Republic of Sri Lanka (Extraordinary)* No. 1053/12 of November 11, 1998 ; I hereby approve the General Rates of Rebate recommended by the Director General of Customs, under the powers vested on the Deputy Secretary to the Treasury by Rule No. 04 of the above rules ; the Schedule of approved rates of rebate is annexed herewith to the notice of the Exporters, Staff of the Commercial Banks and the General Public. Unless otherwise specified, a rate of rebate shall be valid for a period from 01.01.2007 to 31.12.2007.
