THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The boundary lines for the two Lots of land depicted as A and B called “Egoda Arawa Watta” and “Kinigama Kumbura” depicted in the Advance Tracing No. B/BND/2005/101 on 29.07.2005 made by the Superintendent of Survey’s in Badulla situated at Kinigama of Mahapalatha Korale Sub Division within the limits of the Divisional Secretariat, Bandarawela in Badulla District and Province of Uva are as follows:

01. Lot A – Egoda arawa Watta – Extent: 0.167 Hectare

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (3) allotments of lands in total extent of about 0.0023 Hectare, depicted in Surveyor-General’s Advance Tracing No. Gam./Kela./00/265 situated in Pilapitiya village, in Kelaniya Divisional Secretary’s Division in Gampaha District and bounded as follows:

01. Lot No. 04 – Kongahawattha, Assmt. No. cannot be found (a portion) in Baraneskanda 2nd Lane – Extent: 0.0007 Hectare

North: The remaining portion of this land; East: Road; South: Lot No. 03 and Kongahawattha, Assmt. No. 05 in Baraneskanda 2nd Lane claimed by K. Premadasa; West: The remaining portion of this land.
