THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired :

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Description of the land to be acquired :

An allotment of land in total extent of about 0.0328 Hectare, depicted as Lot 'A' to 'D' in the Advance Tracing No. Maha/YTN/2006/549 of 09th November, 2006, prepared by the Superintendent of Survey, Kandy District, situated in the Village of Uda Eriyagama and Gannoruwa in Yatinuwara Ganga Palatha Korale Minor Division in the Divisional Secretary's Division of Yatinuwara in Kandy District and bounded as follows :
