#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land in total extent of about 0.4699 Hectare, depicted in Advance Tracing No. Meda/MPN/2006/119, prepared by the Surveyor-General, situated in the village of Mananthoduwai in the Divisional Secretary's Division of Manmunai, North in Batticaloa District and bounded as follows:
