### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described in Para 1 hereunder is required for a public purpose and that it will be acquired under the provisions of the Land Acquisition Act. The land over which such servitude is to be acquired is described in Para 2.

1. Description of servitude.– Laying of pipe lines for the Water Supply Scheme, Koggala.

2. Description of Land.– Two allotments of land known by the following names and containing in following extents depicted as Lot 01 and Lot 02 in the advance tracing No. GA/HBR/05/1171 dated 02.02.2006 made by the Superintendent of Survey's, Galle and situated in the village of Heenatigala in the Divisional Secretary's Division of Habaraduwa, Galle District, containing in total extent of 0.038 Hectare and bounded as follows:

01. **Lot No. 1 – Godaparagaha Koratuwa alias Kongaha Koratuwa alias Maligahena alias Pansalwatta – Extent: 0.034 Hectare.**

North: Lot No. 5 and 6 in the P.P.
