THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

My No.: 2/4/1/57.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :-

Description of the land to be acquired :

A block of land containing Lot Nos. 314, 315, 316, 317, 318 in extent of 0.2509 Hectare shown in surveyor-General's Plan No. F. V. P. 26 dated 2006.03.02 situated in Trincomalee District, 229 Vellamanel Grama Niladhari Division within the Trincomalee Town and Gravets Divisional Secretariat-Division and boundaries are as follows:
