Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Jeewan Kumaranatunga, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Seven (07) allotments of land called Daisyvally Watta in total extent of about 0.0043 Hectare, depicted in the Advance Tracing No. Ku/MWT/2006/155 and dated 30th June, 2006, prepared by the Surveyor-General, situated in the village of Illukewela in the Minor Division of Weuda Villi Korale in the Divisional Secretary's Division of Mawathagama in Kurunegala District in the North Western Province and bounded as follows:

Lot 'A' – Extent: About 0.0004 Hectare

North: Lot No. 1 of F.V.P. 1106; East: Lot No. 1 of F.V.P. 1106 and Lot B; South: Road (RDA); West: Road (RDA) and Lot No. 123 of F.V.P. 1106.

Lot 'F' – Extent: About 0.0007 Hectare

North: Lot No. 1 of F.V.P. 1106; East: Lot No. 1 of F.V.P. 1106 and Lot G; South: Road (RDA); West: Road (RDA) and Lot E.

Lot 'G' – Extent: About 0.0015 Hectare

North: Lot No. 1 of F.V.P. 1106; East: Lot No. 124 of F.V.P. 1106 and Lot No. 1; South: Road (RDA); West: Road (RDA) and Lot F.
