### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

Reference No.: Thi/DS/IATH/3/30/UDA.

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

Acquisition of Leasing Rights of Sambodhi Temple which is maintained by Sucharitha Movement.

An allotment of land in extent of about 0.3748 Hectare, shown as Lot No. 1 to 5 in the Preliminary Plan No. CO. 8205, dated 31st May, 2000, prepared by the Surveyor-General, situated in Ward No. 36, Kurunduwatta village, within the Municipal Council Limits of Colombo, in the Divisional Secretary's Division of Thimbirigasyaya in Western Province and described as follows:
