#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Chamal Jayantha Rajapaksha, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act. The land over which such servitude will be acquired is setout in Para. II.

01. *Description of Servitude.*— For the laying of the transmission pipe line of the North of Colombo Towns Water Supply Scheme.
