Statement of matters in dispute

The matters in dispute between the aforesaid parties are

- (1) Whether Mr. Sunil Wimalaweera who is presently employed as the Deputy Director - Public Relations at the Urban Development Authority is entitled to get that post from the time of reinstating him in service with effect from 24.04.1996 by the said Authority and if so entitled, to what relief he should be granted and,
- (2) Whether any unjust was caused to Mr, Sunil Wimalaweera being an officer qualified for the post of Director (Progress Review and Public Relations) of

the Urban Development Authority is consequence of creating such a post and appointing an another officer for the said post by the Authority with effect from 15.07.2003 and if there was an unjust, what remedial measures should be taken to grant him relief.
