THE LAND ACQUISITION ACT (CHAPTER 460)**Declaration under Section 5**

I, Chamal Jayantha Rajapaksa, Minister of Agriculture Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude described below is needed for a public purpose and will be acquired under the provisions of that Act.:

Description of Servitude

Laying and maintenance of pipe lines up to the Halloluwagoda underground reservoir from the Koulhena underground reservoir of the Galle Water Supply Scheme.

Description of land

Following two blocks of land containing nearly 0.0024 Hectare in extent depicted as Lots A and B in the Advance Tracing No. GA/SG/AKM/05/1112 dated 24.11.2005, prepared by the Galle District Superintendent of Surveys, situated in the village of Badungoda in the Divisional Secretary's Division of Akmeemana in the Galle District and bounded as follows.
