#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 7

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:
